INSTRUCTIONS FOR COMPLETION OF NON-LICENSED MEMBERSHIP APPLICATION

FEES: CCTNB memberships are being provided on a pro-rated basis until the next renewal date for all members – May 1, 2018. The yearly rate cannot be used, but is provided to show what the pro-rated fees are based. There is no need to send along this page with your membership application. Use it to determine the appropriate fee for your membership category based on the *month your membership will be processed* (the month after you send in your form).

All membership fees are calculated based on the first day of each month. (For example: If your form and accompanying documents are received sometime in January 2018, your membership will be processed for February 1st. Hence your cheque or money order should be chosen from the February 1, 2018 row.)

DOCUMENTATION: Please remember to arrange for any documentation required for your membership to be processed. This must be sent directly from the issuing institution to CLCTNB. Associate members must supply a current resume.
